### Discussion on Possible Rescheduling of ESC (East Side Club) Event

Shari left a phone message and sent an email to the ESC. No word yet. There is concern about how much time the MBS has to get the event rescheduled. Shari checked the ESC contract. MBS also has contracts with the musicians. MBS contract says artists cannot change the date of the show. Furthermore, the position of the MBS is unclear within the ESC contract in terms of cancellation requirements, given that our event was neither a wedding, a weekday, or a Saturday event. ESC got the MBS check on 20Jul2021. The MBS should talk with ESC personnel about what the options are. Eric noted COVID peak anywhere from mid Aug -> mid Oct. A tough situation for all concerned. Perhaps we could reschedule the ESC event for some time in 2022. Eric motioned to reschedule the ESC event. Tim second. Unanimous approval. In retrospect, a major motivating factor for rescheduling the ESC event was general concern for the safety of all who might attend the event. *Shari/Dave will talk with the ESC.*
