Dave will see to this.* Shari wants to get the calendar to the printers next week. Later in our meeting, there was discussion about including a Clyde Stubblefield tribute in the 2022 calendar. Then near the end of the meeting, there was discussion about distributing the 2022 calendars once they have been printed.

Possible meeting with owners of the Red Rooster to discuss our support

Vicki talked to Jesse recently – Yes, they want to talk with us. Wed/Fri are best. Zoom will work. We need to set up a date/time. Dave noted that Wednesday is better than Friday, due to gigs. Vicki will talk with Jesse about meeting on 17Nov2021 via Jim's Zoom. Jim will ask Tim Payne for the four (4) Red Rooster owners email addresses that Jim can then send the Zoom announcement to. Kate noted that we should try not to show favoritism toward any establishment(s). Several other establishment names were noted. MBS needs to keep paying attention to these establishments as the coming winter proceeds.

MBS Newsletter Revisited

Tim suggested promoting the MBS website Live Blues Alert via email to all MBS members.

New Business:

Ballots and Voting

Tim led this discussion. Board terms are straightened out. Tim discussed the ballot and voting documents. Members can only vote for up to 5 candidates. December 6 will be the yearly MBS member meeting. Members can nominate new Board candidates at the meeting, as well as via paper nominations sent in prior via U.S. mail. The basic order during the annual membership meeting will be as follows: President's Report, Board nominations, voting (with a several minute break to allow for the voting), then discussion of the election results.

Amendments to Bylaws

Shari suggested resurrecting the Fundraising Committee and the Education Committee -- actions that require amendments to the MBS Bylaws. The Education Committee deals with items such as donations to schools, scholarships, Blues Kids, Blues in Schools, etc. The MBS needs to send out both the current MBS Bylaws language and the new amendment language to the MBS membership ahead of the December 6 general membership meeting. Tim will work on the wording for the bylaws amendment.

Other Business:

Shari talked about having virtual seminars. Kate talked about producing musician shows that could be presented virtually. Kate also noted that people could ask on Facebook for contributions on their birthdays for Blues-related causes.

In memoriam: Dave noted the passing of past MBS membership coordinator Rick Jones on August 11, 2021. Rick was a trailblazer in communicating local blues news to Madison area enthusiasts.
